CHAMPION LACROSSE ENROLLMENT AGREEMENT & RELEASE

The Participant desires to participate in a program of Premier Sports Group, Inc., doing business as Champion Lacrosse ("Champion"). **This form is an important legal document. It is critical that you read and understand it completely. After you have done so, please print your name legibly and sign below.** In this document, the term "Participant" includes both the on-the-field Participant and the parent or legal guardian, if Participant is under 18 years of age.

Participation in the sport of lacrosse may result in injury or death to Participants. Participant desires to participate in the sport of lacrosse despite these risks. Participation in the Champion program is expressly conditioned upon the following agreement by the Participant:

1. Participant assumes all risks of injury or death sustained while participating in the sport of lacrosse or while on or about the premises, and waives all liability against Champion, the Birmingham Public Schools, the Bloomfield Hills Public Schools, Ann Arbor Parks and Rec, The JCC their officers, employees & all affiliated entities.

2. Participant releases, discharges, indemnifies and holds harmless Champion, the Birmingham Public Schools, the Bloomfield Hills Public Schools, Ann Arbor Parks and Rec, The JCC, their officers, employees, agents, officials and all related entities from any and all claims, demands or causes of action that are in any way connected with participation in the sport of lacrosse or use of the premises, facilities or equipment, and including any negligence on the part of Champion, the Birmingham Public Schools, the Bloomfield Hills Public Schools, Ann Arbor Parks and Rec, The JCC their officers, employees, agents, officials and all affiliated entities.

3. Champion is not responsible for Participant's fitness, abilities or equipment.

4. Participant represents and acknowledges that Participant has adequate insurance and agree to assume full responsibility for any and all costs or expenses occasioned by an injury or medical need arising out of participation in the sport of lacrosse or use of the premises, facilities or equipment.

5. Participant acknowledges that during the course of their activities, Champion may take Participant's photograph or video. Each Participant hereby grants Champion permission to use any such photograph or video for use in materials promoting Champion. Such use may include publication in program, general advertising, posters, flyers, television and any other vehicles that may be distributed or shown to or otherwise seen by large numbers of individuals and potential patrons of Premier Sports Group or Champion Lacrosse. Participant waives all rights to any financial remuneration of any kind.
